2. COMPOSITION/INFORMATION ON INGREDIENTS

The product contains: acid, additives and water.

This product is covered by the OSHA Hazard Communication Rule 29, CFR 1910.1200

3. HAZARDS IDENTIFICATION

Human health: Corrosive to skin and eyes. Spray mists irritate the respiratory system, and cause coughing and difficulties in breathing. Inhalation of mist may cause lung oedema. This product contains no ingredient listed on the NTP, OSHA or IARC carcinogen lists.

Environment: The product may affect the acidity (pH-factor) in water with risk of harmful effects to aquatic organisms.

4. FIRST-AID MEASURES

Inhalation: Move injured person into fresh air immediately. Call an ambulance. Be aware that lung oedema may occur up to 24 hours after exposure. Bring along these instructions.

Skin contact: Flush immediately with plenty of water and remove contaminated clothing. Call an ambulance. Continue flushing during transport to hospital. Bring along these instructions.

Eye contact: Immediately flush with plenty of water. Remove any contact lenses and open eyelids widely. Call an ambulance. Continue flushing during transport to hospital. Bring along these instructions.

Ingestion: Immediately rinse mouth and drink plenty of water. Call an ambulance. Bring along these instructions. Do not induce vomiting.

5. FIRE-FIGHTING MEASURES

- Extinguishing media: Cool containers exposed to heat with water spray and remove container, if no risk is involved. Use fire-extinguishing media appropriate for surrounding materials.

6. ACCIDENTAL RELEASE MEASURES

- Personal precautions: Avoid inhalation of vapours and contact with skin and eyes. Look out! The product is corrosive. For personal protection, see point 8.
- Environmental precautions: Do not discharge into drains, water courses or onto the ground.
- Methods for cleaning up: Flush away small spillages with plenty of water. Large spillages: Dam and absorb spillages with sand, earth or other non-combustible material. Flush contaminated area with plenty of water. For waste disposal, see point 13.

7. HANDLING AND STORAGE

8. EXPOSURE CONTROLS/PERSONAL PROTECTION

Engineering measures: Provide adequate ventilation. The risk of inhalation of vapours and spray mist must be minimized as much as possible. An eye wash bottle must be available at the work site. Provide easy access to water supply or an emergency shower. Risk of inhalation of spray mists must be limited as much as possible.

Respiratory equipment: Risk of inhalation of spray mist: Use air-supplied respirator.
When diluted 1 part of CPS Stencil Remover Concentrate with 50-70 parts of water (ready-to-use mixture):
Risk of inhalation of spray mist: Use respiratory equipment with particle filter, type P2/P3.
